All that certain lot, tract or parcel of land lying and situated in the Joel Hodges Headright Survey, Abstract 702, the M.F. Jones Headright Survey, Abstract 945, and the F.V. Evans Headright Survey, Abstract 742 and being more particularly described by metes and bounds as follows:

BEGINNING at a 1/2 inch steel rod found for a corner, lying in the current City Limit Line of Texarkana, Bowie County, Texas (the "City Limit Line"), the Northwest corner of that certain tract of land being described as 6.888 acres in deed from Lonnie Hawkins, et ux, to Lonnie J. Hawkins, dated February 16, 2017, recorded in Document No. 2017-1980 of the Real Property Records of Bowie County, Texas, the Southwest corner of Block 2 and the East line of Block 3 of the Stonevale Addition according to the plat recorded in Volume 5577, Page 99 of the Real Property Records of Bowie County, Texas;

THENCE North 88 degrees 33 minutes 48 seconds East, a distance of 624.63 feet along the City Limit Line, the North line of the said 6.888 acre tract and the South line of Block 2 of the said Stonevale Addition, to a 1/2 inch steel rod found for a corner the Northeast corner of the said 6.888 acre tract, the most Southerly Southeast corner of Block 2 of the said Stonevale Addition, the Southwest corner of that certain tract of land described as 0.083 (Tract 3) in deed from Lonnie Hawkins, et ux, to Juli Cean Akin, dated February 16, 2017, recorded in Document No. 2017-1979 of the Real Property Records of Bowie County, Texas;

THENCE North 02 degrees 49 minutes 17 seconds West, a distance of 9.82 feet along the City Limit Line, the South line of said Block 2 of the Stonevale Addition, the West line of the said 0.083 acre tract, to a 1/2 inch steel rod found for corner, the inside ell corner in the South line of said Block 2 of the Stonevale Addition, the Northwest corner of the said 0.083 acre tract;

THENCE North 88 degrees 33 minutes 48 seconds East, a distance of 406.06 feet along the City Limit Line, the South line of said Block two of the Stonevale Addition, the North line of the 0.083 acre tract, and crossing the West right-of-way line of Richmond Road (F.M. 559), to a point for corner, lying in the centerline of said Richmond Road, at the beginning of a circular curve to the right;
