II. DISCUSSION OF MASTER FEE LIST FOR FY2016

Mayor Bruggeman opened the meeting welcoming all in attendance. Mayor Bruggeman told the audience that the meeting was to allow further council discussion, gain input from citizens and review the updated information that staff would present. There will be more council meetings in the future for added discussions of the proposed FY16 Master Fee List. Mayor Bruggeman then turned the discussion over to City Manager Whitson.

The City Manager began by proposing a new concept for sign permit fees, defining the process regarding fees in much simpler terms. Representatives from the local sign companies were agreeable to the new fee structure proposed for signs. Next, the City Manager reported on the findings of staff research in regards to setting the construction fees. Staff found cities similar in population and demographics for comparison. Again, the City Manager mentioned that the city has less than the tax base for use in the city's general fund due to the TIRZ. After showing the council some charts and graphs, council began review of the newly proposed development fees. As a result of this discussion, adjustments were made on the fee schedule that were amenable to city staff and developers.

The City Manager briefly discussed and proposed a new concept for a funding source for the Texarkana Regional Airport that council could consider in the future. Fire Chief Eric Schlotter gave an update, at the request of Council Member Davis, on various fire related fees.

The council finished reviewing the remainder of the fees. Mayor Bruggeman announced that Public Workshop #3 of the Master Fee List Review, scheduled for Thursday, June 4, 2015 at 5:30 p.m.,

would be cancelled as this session completes the review of all the fees on the proposed FY16 Master Fee List.

Representatives from the sign companies expressed their thanks for the proposal and clarity of the new sign permit fees.

The developers asked for no base fee but a flat fee of 50 cents per square foot regardless of the size of square footage. They also asked for a simple chart breaking down approximate fees based on the cost of the project. This would help bring clarity to their clients as they bid jobs.

Overall, the audience was pleased that the city listened to their concerns and thanked the council and city staff for simplifying the fee schedule and offering reasonable fees for the benefit of all.
